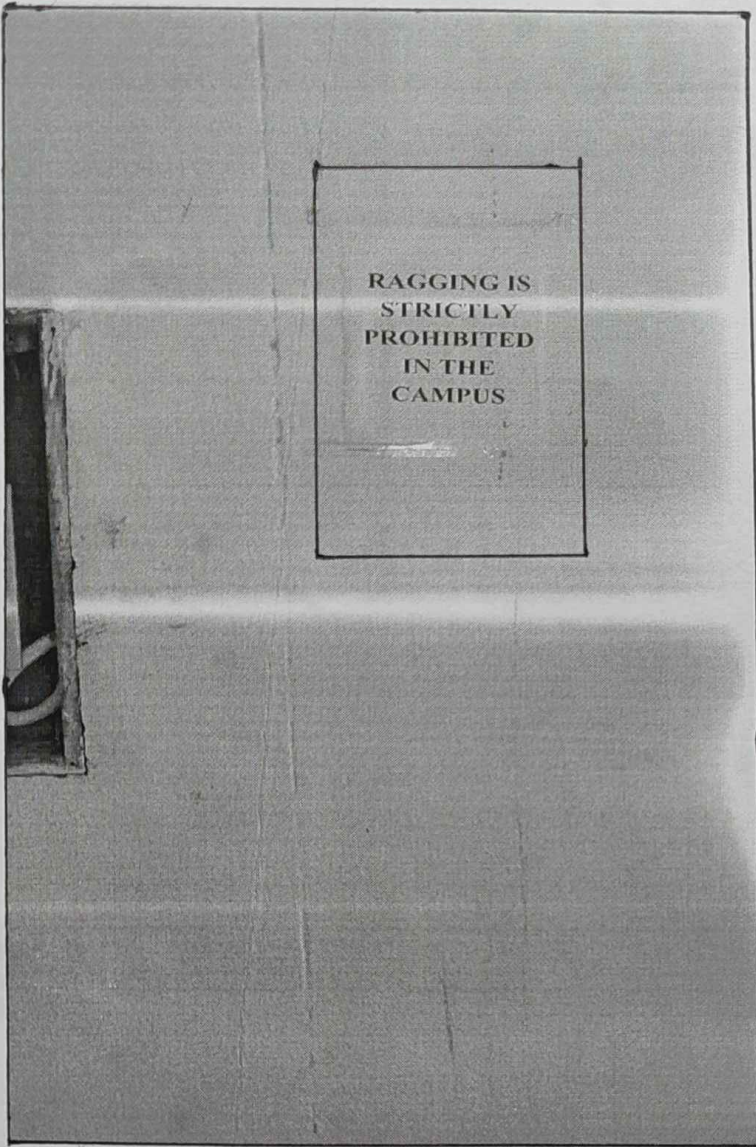
1. The committee should consist of senior faculty, headed by principal.
