- 1. The institute is not authorized to start new course/ increase or decrease in sanctioned intake/ closer of course without prior approval of the University.
- 2. Adequate funds shall be available with the Institution to meet the financial obligations of recurring and non-recurring nature as prescribed by the university, from time to time.
- 3. The College shall have to create the necessary infrastructure as per the norms prescribed by the University/UGC/AICTE for running the above courses during the session 2021-22 and onwards.
- 4. The institute shall have to maintain student faculty ratio (SFR) and other facilities like laboratories, computers centre, library etc. as per the UGC/AICTE/PCI/CoA/University norms prescribed from time to time.
- 5.
